MEETING OF BOARD OF EQUALIZATION & REVIEW

Mrs. Sandy Brock-Justice, Hertford County Tax Assessor, shared with the Board of Equalization & Review that Market Memorial Realty, LLC, Parcel ID # 5992-75-1308, elected to provide their defense in writing due to the COVID-19 pandemic, which was distributed to the Board. The assessor stated her position, which was a recommendation of no change in value, by reading a letter, which was presented to the Board along with a packet of information for review. The Board decided to take all of the written information under advisement, and after review, consider a decision at their next meeting.

On a motion by Com. Lassiter and second by Vice-Chair Horton, that Board of Equalization and Review unanimously approved to reconvene the meeting of the Board of Equalization & Review on June 15th.

On a motion by Com. Lassiter and second by Vice-Chair Horton, the Board returned to Regular Session.

FY 2020-2021 ANNUAL BUDGET PRESENTATION

Interim County Manager Cotton presented FY 2020-2021 Annual Budget noting the following recommendations: General Fund - \$26,782,157; Proprietary Fund Solid Waste - \$1,236,428; Propriety Fund Northern Rural Water District - \$555,951; Proprietary Fund Southern Rural Water District - \$1,181,956; Proprietary Fund Tunis Wastewater District - \$36,499; other Governmental Funds - \$390,623; total (inclusive of all, net of transfers) Funds-\$30,183.614; a proposed tax rate of .84 cents per \$100 in valuation. He stated that his proposal demonstrate diligence, balance, leadership, sacrifice, prudence, responsiveness to the citizens' expectations and demand for services. Interim Manager Cotton also shared that with purpose and assiduousness, the 20-21 budget illustrates the incorporation of the guidance, goals and objectives served as the keystones for the development of the budget plan. In closing, Interim Manager Cotton shared that staff meticulously worked to ensure that a rational nexus was made to incorporate the goals and guidance identified by the Board.

Chairman Gatling stressed the importance of being certain that the budget was a balanced budget and a stabilized fund balance.

The Board thanked Mr. Cotton for the 2020-2021 Annual Budget presentation.

Chairman Gatling announced a Special Budget Work Session scheduled on Thursday, June 4th at 1:00 p.m.

On a motion by Com. Douglas and second by Com. Lassiter, the Board unanimously approved to schedule the Budget Public Hearing for June 15th at 7:15 p.m.

INTERIM COUNTY MANAGER'S COMMENTS

Interim Manager Cotton made no comments.

COMMISSIONERS' COMMENTS

No comments were made by Com. Lassiter and Com. Douglas.

Vice-Chair Horton thanked everyone for attending the meeting in light of everything that is occurring around the Nation.

Chairman Gatling commented he received several letters regarding the Parker's Ferry operation and the ferry not being returned to harbor in the County. He requested Interim

Manager Cotton to contact NCDOT in regards to those concerns. He also requested Clerk Fleetwood to check on the status of the Hertford County Tourism Development Authority resolution with the House of Representatives office.

On a motion by Com. Lassiter and second by Vice-Chair Horton, the Board unanimously approved to move to Close Session to consult with the County Attorney as allowed under NCGS § 143-318.11(a)(3).
